TERMS & CONDITIONS AND PRINCIPLES OF USE OF THE APPLICATION

§ 1. Information and general regulations

Using an application, you accept these rules and the rules of the contest or application determined by the fanpage owner, where application is installed.

§ 2. About the authors

1. Applications, created by clickcommunity have names starting with „click” (click album, click shop, etc.) and are available from the level „click install”. All of those applications will be called later as „Application” or „Applications” and all of them are subjected to that Terms and Conditions.
2. The founder and sole owner of the rights to the Application is clickcommunity sp. z o.o. headquartered in Kraków, ul. Szlak 77/222, 31-153, Kraków, registered in the National Court Register in Poland by the District Court for Kraków-Centre in Kraków, XI Commercial Division, under the KRS number: 0000416255, later in this document, the company will be called "clickcommunity"
3. Clickcommunity has reserved the right to all names of their applications, source code, graphics of admin panel and CMS. Impersonating names of click apps applications, unauthorized use of the source code, copy, copy the name, logo, glaring similarity functions, etc. may be in violation of the law and, as such, will be enforced.

§ 3 Time and place, where click community shares their applications to other users.

1. Using the application by the final user is free of charge.
2. Click community sp z o.o. forbids the user to intervene in the application source code and copy it, especially in order to achieve the benefits. The actions described in the preceding sentence will be tantamount to an infringement of copyright to click community and the rights of intellectual property and commercial law.
3. Click community declares that the promotion is in not supported, sponsored, or administered by Facebook, or in any way connected with this service, which is only the platform for the proper functioning of most of the applications created by the click community.

§ 4 Proper operations of the Application

3. Click community do not archive and administer image files and text information entered into the application by users, that are shared by them.

§ 5 The right to use the Application is granted to people who:

1. Are Facebook.com users in accordance with the terms and conditions and privacy policy of Facebook, which reported a real personal data in the installation process and make their application data.
2. Allows click community and administrators of the application to access their basic information (including the reported name and e-mail address), and / or allow access to the other information contained in the request for authorization dialogue that has been clearly stated in the query.

§ 6 Prohibition violations and User Statement

1. Click community reserves the right to remove the application or installation of the application in which user save links to content or content contrary to the Regulations, the law, rules of social life, morality, violate the rights of third parties or which are offensive, vulgar, containing threats directed at third parties that contain discriminatory gender, race, nationality, language, religion, inciting violence or having pornographic. User proclaims, that the content uploaded in the process of personalizing the Application do not violate any rights of third parties, including the particular economic rights under the Polish Act on Copyright and Related Rights from February 4, 1994 (consolidated text from 17 May 2006. Journal of Law, No. 90, item. 631 with later amendments).
3. User is fully responsible to the Organizer and third parties, if his content in the Application (graphics, text, links) violate the right of third parties.

2. Administrator of personal data is a click community Sp. z o.o. placed in Krakow.

Administration or disclosure of personal data (first name, last name and email address of the participant and the name and age of the child) is optional, but necessary to install the application as well as the need to use the end-user with some applications, especially contest applications. Users have the right of access to information and the right to correct them.
